She serves on the board of In Progress, a youth media organization, as Policy Committee


Chair of the Strategic Leadership Team for Youth Community Connections in addition to numerous other civic and community leadership roles.

George Latimer was the long-time mayor of Saint Paul, Minnesota from 1976 until 1990. Born in Schenectady, New York, Latimer attended Saint Michael's College and Columbia Law School. He practiced law in Saint Paul from 1963 until he was elected mayor.

After his mayoral tenure, he served as dean of Hamline University's law school from 1990-1993, and as a special advisor to Henry Cisneros, President Bill Clinton's Housing and Urban Development Secretary, from 1993-1995. An expert on urban affairs and development, George has been a visiting professor of urban studies and geography at Macalester College in Saint Paul since 1996.

The Saint Paul Central Library was re-named the George Latimer Central Library by former mayor Chris Coleman in 2014.
